



## **Minnesota Beautiful Program 2010**

in Northeastern Minnesota

A Project of the Northland Foundation and the Valspar Foundation

### **Eligibility and Program Requirements**

Minnesota Beautiful Program is a project where communities in the seven county area of northeastern Minnesota can apply to receive grants of paint or coatings provided by the Minneapolis-based Valspar Corporation to complete various restoration and beautification projects. The program is being administered by the Northland Foundation in partnership with Valspar. A goal of the program is to encourage local volunteer involvement in the painting process.

#### **Eligibility Criteria**

- Projects will be selected based on how well they meet the following criteria:
  - visual impact of the project
  - public benefit to the community
  - volunteer participation and support
  - current and/or intended use of the structure
  - benefit to the needy
- Projects that may qualify include but are not limited to:
  - historic buildings, structures, or landmarks
  - facilities for senior or disabled citizens
  - community centers or other public buildings
  - murals or other visual impact projects
- Projects not within the scope of this program include denominational churches, city maintenance, schools (with the exception of school mural projects), or privately owned facilities that do not meet any of the above criteria. Projects using contractors to complete the work are not eligible (with the exception of muralists or artists working with community volunteers).
- While we encourage organizations to submit applications for the total number of gallons needed for their project, Valspar reserves the right to limit awards.
- The application process is not intended to be tedious. However, because of the large number of applications received, it is important that you carefully read and follow instructions. Incomplete applications will not be considered. If any part is not clearly understood, please contact the Northland Foundation for clarification.

## **Requirements**

- Applications must be received by **March 5, 2010** with two copies of all materials. Photographs (not slides) must accompany each copy. Awardees will be notified by March 30, 2010.
- Awardees are expected to attend an orientation session in Duluth with Valspar representatives in April to discuss technical issues of the project, make decisions on color selections, and finalize project details.
- Awardees are expected to provide transportation from St. Paul/Minneapolis for all paint products received.
- Volunteers must be geographically located within the Northland Foundation's seven-county service area of Aitkin, Carlton, Cook, Itasca, Koochiching, Lake, and St. Louis Counties.
- All selected projects **must be completed by November 1, 2010.**
- A final report must be provided to the Northland Foundation as soon as the project is completed, but no later than November 30, 2010.
- Site visits may be conducted prior to an award and/or conducted during and after project completion.
- Public announcements will be issued highlighting the project on behalf of the recipient and other recognition events may also be planned.
